Fees and Fundraising

Technology Fee

\$100/student

Each student is assessed a technology fee. This fee helps to support the cost of items including, but not limited to, technology refresh, student devices/accessories such as iPads and Chromebooks, software licenses, and monitoring software.

Home & School Association Fee

\$30/student

Each student is assessed an HSA fee to help with the cost of classroom parties, teacher gifts, HSA sponsored events, etc.

STS Portal Fee

\$45/student

Each family is assessed this fee to cover the enrollment costs for Simple Tuition Solutions, our tuition company.

Active Parishioner Discounts

Catholic Parishioner Discount

\$1,180

Awarded to each student whose family are active parishioners of their parish within the Diocese of Harrisburg. Active parishioner families are those; registered with a local Diocese of Harrisburg Catholic parish, who attend Mass each Sunday and on Holy Days of Obligation, and who are stewards of their time, talent, and treasure in the life of their parish communities.

Families must complete the required Parish Affiliation form and have it signed by their pastor. If you do not have a signed form, you will be charged the non-Catholic rate. Individual parishes will determine active parishioner status, not SJS.

SJS Multi-Child Discount

\$700

Awarded to Catholic families with more than one K-8 student. The second K-8 student and all additional enrolled K-8 students receive this scholarship.

Optional Catholic Scholarship Opportunities

Participate in EITC/SPE or Apply for Financial Aid

\$1,500 (\$500 each add'l child)

Awarded to each student whose family/caregiver: 1) Submits a Neumann financial aid application, or 2) Participates/provides funding towards the Educational Improvement Tax Credit (EITC) and/or SPE (Special Purpose Entities) program with funds going to St. Joseph School.
